## 5. Matters arising from previous minutes

Geoff reminded everyone that the key action of last year's minutes was constitutional change and that the changes were as per those discussed in the morning workshop to be covered off by the following motion:

"That the revisions to the 2012 constitution (as outlined in the draft 2016 constitution within your AGM pack) be accepted as tabled, but conditional on checking that proposed revisions continue to meet charitable status, and also after checking the legal status of incorporated membership (4.1) and changing as necessary"

#### 6. Chairperson's Report

Chairperson's Report read by Geoff Ensor.

Geoff spoke to his report acknowledging the difficulty of the last two or three years and acknowledging the fact that the Board has stayed united in the way forward which has helped to enable the organisation to progress with such strength. He thanked MSC's funders for their confidence in MSC and their on-going support without which we would not be able to continue. He thanked the Council members for their support and also the MSC operations team, especially Mike Daisley and Nathan Watson for their leadership, but also the rest of the team for the expertise they now bring to the organisation.

He said that we must continue to work at removing the idea that the safety message will stop participation – to pitch the outdoors as a great place to go interspersed with how to participate safely whilst there and continue to work at how to get the message of personal responsibility and our duty of care as an organisation properly balanced. He also said that it was time to look at technology and its place in the future.

He thanked the operations team for their thoughtful and sensitive approach to the media and emphasised how appreciative the Board were for the confidence this instilled in them.

He concluded that now is the time to maintain the momentum of a high quality collaborative approach that will not be compromised by quantity becoming the goal – quality over quantity.

## 7. Chief Executive's Report

Chief Executive's Report read by Mike Daisley.

Mike reiterated some of the achievements that MSC has seen throughout the year and added that the more behind the scenes evidence of our success is that the media is no longer being reactive and just coming to us when someone dies or there is an incident, they are being proactive with messaging before the events occur.

He also added that the translation of the Day Walks Activity Guide into other languages was from collaboration with Tourism NZ and Tourism Industry Aotearoa who understand the market and can therefore assist us in aiming it at the correct languages, that these types of partnerships will be our way forward into the future.

He said the growing local government relationships in hot spots was also a direct result of them seeing our insights and wanting to collaborate with us in preventing what is happening in their areas and that these partnerships would only deepen over time.

He briefly mentioned the Firearms Safety Review that is continuing with the NZ Police and our continued hope that the influence of MSC in this area will continue into the future regardless of the outcome of the review.

Mike Daisley spoke to why the three new members are important – MetService for their deep analytical thinking and Crown level advocacy ability; NZ Recreation Association so that we can move into a deeper partnership with their local government and regional sports trusts network, to better understand the recreation industry and to keep the safety message alive throughout the whole outdoor recreation network in a more relevant way; and William Pike so that we can begin to target the younger primary aged children in a new direction for us.

Peter Lennox, CEO of MetService spoke and said how thrilled they have been with their involvement with MSC with our shared ethos of social responsibility and protecting lives. It made sense to open up a relationship and now deepen it with an organisation that shares their outlook and purpose.

Andrew Leslie, CEO of NZ Recreation Association said that our joint advocacy perspective will enable us to see what the overall challenges are for the whole outdoor recreation industry to be able to move forward united in purpose.
