Matters arising from previous meeting minutes – 11th October 2013
Bill O'Leary, Hunts Committee Convenor, referred to the OneMSC changes and that this wasn't recorded as a Motion or noted in detail in the minutes.

Mike Daisley responded that the changes had been fully discussed in the workshops that were held prior to the AGM and that a clear mandate to change was drawn together for the future direction of the organisation. Council had strived to get agreement at the workshops and the mood of the meeting was a resounding 'get on with it'. This wasn't recorded as a Motion but was recorded in meeting notes taken at the time.

Bill O'Leary, Hunts Committee Convenor asked that the mood of the 2013 meeting, which should have been captured as a Motion, be tidied up at this AGM.

7. Chairperson's Report

The Chairman's report was accepted as tabled. Geoff commented that it was very important we don't lose momentum and continue on with the changes ahead while also retaining the respect and support of those we interact with.

8. Chief Executive's Report

The Chief Executives report was accepted as tabled. Mike commented that the report told a compelling story of a willingness of people to try new things, even when not comfortable with them and a willingness to look to the future.

9. Financial Report presented by Doug Haines, BDO

A memo prepared by BDO on the 2014 Financial Report for AGM attendees was circulated. Doug then addressed the meeting explaining that BDO had recently been engaged to manage the finances for MSC. He acknowledged the generous help provided by branches following a request at the last AGM, to meet a funding shortfall for the Outdoor First Aid programme.

There was a small surplus this year and MSC hopes to be able to pass money back to the branches who generously met the funding shortfall for the Outdoor First Aid programme. However, this is dependent on further financial review.

BDO will work with the board and management to work through the Audit Management Report and address the issues raised in the letter.

A small operating profit was recorded \$57,000 (2014), \$29,000 (2013). There was an



increased net loss for the year \$64,000 (\$2014), \$51,000 (\$2013) and this relates to depreciation of assets. Closing equity \$698,000 (2014), \$761,000 (\$2013).

There was discussion from the floor, with Robin McNeill, (Federated Mountain Clubs) seeking assurance that Council has addressed the loss situation. Murray Douglas, Deputy Chair responded that we do have a budget and business plan and we are driving the organisation to ensure that it doesn't continue to 'burn cash' and MSC wants to maintain a cash surplus.

Robin McNeill commented that they had an expectation that things would level out - subject to the changes. He was concerned that AGM attendees had not been provided with a full set of accounts and noted that the FMC needed to know that MSC is in a sound financial position. Robin also asked for the financial accounts to be made available to attendees in advance of the next AGM. Geoff Ensor responded that full checks were in place but noted that the transparency comment was well made.

There was further discussion on the level of cash reserves, how much is sufficient, and the challenge to build reserves while still being able to seek funding from providers.
